2019 Course Catalog Addendum

This catalog addendum contains new and updated information, as well as corrections of errors in the original catalog. These changes replace what is printed in the current catalog and are effective as of the Summer 2019 term. The left column indicates whether a section is an addition or replacing existing text and where the original sections appear in the Summer 2019 Course Catalog. Text being replaced is highlighted in yellow.

Page 93, Course Withdrawal Policy

ORIGINAL TEXT

■ **Course Withdrawal Policy**

BFA Program students may withdraw from a course within the second to the fifth week of the semester start by submitting the Add/Drop form. A Withdrawal (“W”) will be recorded on the student’s official transcript record. Tuition charges are unaffected. The withdrawal policy is as follows:

Week 1:	Students may add or drop courses within the first five days of the semester.
Weeks 2-5:	Students who withdraw from a class during the second through the fifth weeks will have a “W” (Withdrawal) recorded.
After Week 5:	Students who withdraw from a class after the fifth week will have a “W/F” (Withdrawal/Fail) recorded. A W/F affects the student’s GPA.

REPLACEMENT TEXT

■ **Course Withdrawal Policy**

BFA Program students may withdraw from a course within the second to the eleventh week of the semester start by submitting the “Add/Drop” form. A Withdrawal (“W”) will be recorded on the student’s official transcript record. Tuition charges are unaffected. The withdrawal policy is as follows:

Week 1:	Students may add or drop courses within the first five days of the semester.
Weeks 2-11:	Students who withdraw from a course during the second through the eleventh week will have a “W” (Withdrawal) recorded.
Weeks 12-14:	Students who withdraw from a course during the twelfth through the fourteenth weeks will have a “W/F” (Withdrawal/Fail) recorded. A W/F affects the student’s GPA.
Week 15:	Students may add or drop courses related to the upcoming semester.

Page 95, Withdrawal-Fail Policy

ORIGINAL TEXT

Applicable after the fifth week of the term to BFA Programs only: Students who opt to withdraw from a class after the fifth week of a term will have a “WF” (“Withdrawal-Fail”) posted on their official record.

NEW TEXT

Applicable after the eleventh week of the term to BFA Programs only: Students who opt to withdraw from a course during the twelfth through the fourteenth weeks will have a “WF” (“Withdrawal-Fail”) posted on their official record.

Page 104, Impact of Course Grades and Status on SAP, Withdrawal-Fail (BFA Programs only)

ORIGINAL TEXT

Students who opt to drop a class after the fifth week of a semester will have a “WF” posted on their official record.

NEW TEXT

Students who opt to withdraw from a course during the twelfth through the fourteenth weeks will have a “WF” (“Withdrawal-Fail”) posted on their official record.
